

# UNIVERSITY GUARDIANSHIP

Most universities in the UK require all students that join them who are under 18 years of age to have a local appointed guardian as part of their admissions criteria.

Guardians International as a leading provider of guardianship services in the UK has developed a flexible program to support the student application and ensure that any student under 18 has access to the support they need.

#### OUR FLEXIBLE APPROACH

Initially Guardians International will act as your nominated guardian as required for the application process for as many universities as the student decides to apply for – this can either be via UCAS or directly.

For us to provide the above service, the student and their parents will need to register with us and complete a parental agreement — no payment is needed at this stage.

Once the student has received an unconditional or guaranteed offer of a place at a university and they know they will be accepting, they notify us and decide on the service package that best suits their needs; Basic or Full.

Upon notifying us of the university choice and service package an invoice is issued for payment.

Upon receiving payment we notify university admissions that we are acting as the student's UK guardian and a guardianship letter is issued. Upon arrival in the UK a welcome pack is dispatched to the student which includes; Guardianship ID, Luggage ID, Guardianship letter, and guides and advice for living and studying in the UK along with other important information. The next steps depend upon the service package chosen (see overleaf).





# UNIVERSITY GUARDIANSHIP FEES

Within the student welcome pack will be the students name(s), Guardians International Coordinator (GIC), with all of their contact details and emergency number(s).

On all service packages a communication group is established which includes the GIC, the student and preferably a parent. We tend to use WhatsApp or WeChat as these are easily accessible by all parties, especially when outside the UK.
